### **15. PLACEMENT OF A REGIONAL DISASTER PREPAREDNESS OFFICER**

### **RECOMMENDATION:**

That the Board note the information provided by Chris Presland, Director and David Butt, Senior Manager Emergency Management Preparedness on the regional placement of a Regional Disaster Preparedness Officer

### REPORT

- It is proposed that a Regional Disaster Preparedness Officer, funded by NSW Office of Emergency Management, be placed in this region for 2 years.
- The exact location for placement of the Officer is still being considered
- Officers are being placed in regions with high impact of disaster and where there is a good level of engagement, such as the Mid North West Hunter and the South East NSW
- The Officers will lead development of a pilot program in partnership with the MNCJO. In our region the pilot will cover an area that crosses the boundaries of 6 Local Councils being Clarence Valley Council, Nambucca Shire Council, Port Macquarie-Hastings Council, Kempsey Shire Council, Bellingen Shire Council and Coffs Harbour City Council
- David Butt will line manage the pilot program
- The Pilot's objective will be to deliver a Regional Disaster Preparedness program, from initial risk assessment, right through to community engagement and the post disaster recovery phase.
- The Pilot will be benchmarked and evaluated, with a view to using the learnings to rollout a similar program in other areas of NSW.
- Recruitment process to be completed by end December, with a view for Officer to start in January 2020
- A Steering Committee is to include members from MNCJO,MIDROC,OEM, RLE and Regional NSW
- \$1.3 million has been obtained from Commonwealth- \$400,000 assigned to each of the 3 selected regions to cover salary costs and approx. \$100,000 for seed funding /other costs.

• Outputs might include the *Get Ready* Collateral, Emergency Risk Assessment tools, a range of training products, a Disaster Preparedness Website, all of which may perhaps be branded by the MNCJO

For the North Coast, nine regional systems were identified as particularly vulnerable and in need of change to ensure effective ongoing government service planning and delivery:

- Settlements and land-use planning
- Resilient communities
- Cultural heritage
- Biodiversity
- Emergency management
- · Food and agriculture
- Infrastructure and water
- Energy
- Tourism.
